Online registrations will be offered by *Cross Training* for the discounted price of \$55 for your group.
2. Deposit will be returned to the group/organization within 7 business days post-camp. If a group/organization reserves 20 spots but only registers 18 spots, the group/organization will receive a deposit return for 18 spots and the unused ticket deposit will be non-refundable.
3. For the Ultimate Athlete Day Camp, there will be a max of 50 available spots. Your group/organization can hold spots based on availability.
4. Group/Organization leaders attend as chaperone at no cost.
5. In order to HOST A CAMP at your facility, Group/Organization hosting camp must commit to 20 reserved spots.
6. Hosting Group/Organization will receive a 25min talk for group/organization prior to camp.
7. Travel expenses will be covered by hosting group.
8. Individual Registration is on *Cross Training* website.

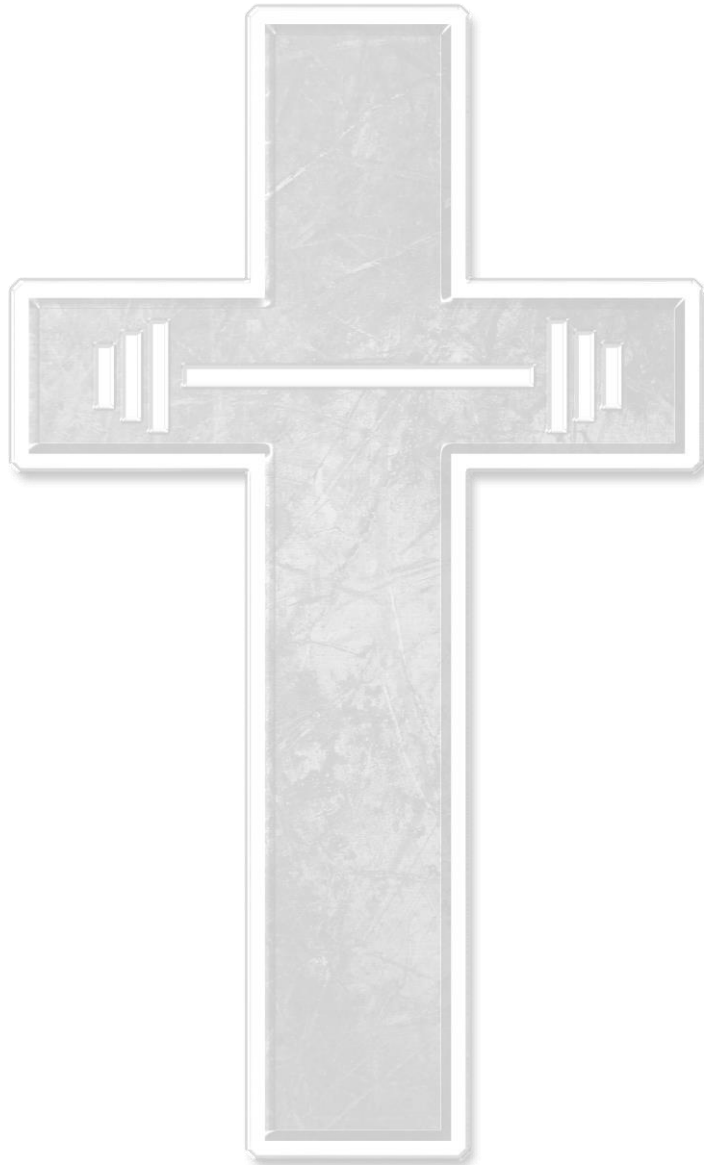
Groups participating in Ultimate Athlete Day Camp will receive a 25% discount on established speaker fees if they wish to have a Cross Training speaker come to speak for their group or at their events.

Cancellation Policy: Group/Organization has up to 14 days prior to scheduled camp date to cancel without paying the remaining camp fee. Within 14 days of the camp, group/organization is committed to the payment of the camp corresponding with the number of registrations. If Group/Organization wishes to cancel camp within the 14 days prior to camp date, they are committed to the remaining balance corresponding with a 10 person camp.

Policy varies for groups/organizations registering for 75 people or more.

Date Change: Once the camp is scheduled, if a date change is necessary, the participating body may change the date within 7 days of registration without the date-change fee. The participating body may change the date up to 14 days before the scheduled camp date. A \$200 change-date fee will be issued to

cover new marketing materials, registration forms, and potential staff changes. (* Date change with-in 14 days will be considered if unforeseen circumstances occur on the part of the group/organization).
